### SUPPORT OPERATIONS RESCUE WATERCRAFT OPERATORS

Rescue Watercraft (RWC) operators are part of the support operations group of Surf Life Saving Central Coast whose core objectives are;

1. Incident Response – the provision of coordinated response assets with dedicated command and control during and out of the surf season, including out of hours call outs.
2. Surf Sports – the provision of power craft water safety support during nominated carnivals.
3. Community Education – supporting SLSCC community educators to develop lifesavers of the future.

Operators are posted to one of five locations across the region from where they will deliver core services such as rostered patrols, water safety, incident response and support community education programs.

RWC operators will be called upon by Branch and State Duty Officers to take command of on-water activities and are also expected to work with minimum supervision, in all weathers throughout the season, responding to call outs throughout the year.

## EXPRESSIONS OF INTEREST

Expressions of interest are being sought from experienced life savers to undertake Rescue Watercraft (RWC) training.

Induction will take place on Sat 1st June 2024 and Training will run for approximately 12-15 weeks (weather depending). To be considered for this course those interested should meet the following criteria.

Essential Skills:	Required Experience:
Be at least 18 years of age with demonstrable leadership skills and experience	Be of a mature character with the ability to work unsupervised and independent but accepting of direction from others (D.O.'s & Police)
Current and valid NSW Driver's License	Minimum 1-year experience towing a trailer and reversing a trailer.
Current proficiency of SLSA Bronze Medallion/Certificate II	Minimum 80% SLS Club Patrol attendance in each of the previous 2 seasons leading up to the RWC course.
Current Silver Medallion IRB Drivers Certificate	Experience driving a SLS IRB in the seasons leading up to the RWC course.
Radio Operators Certificate	Experienced and capable user of radio communications equipment.
Current SSV Induction	Demonstrated SSV capability on differing beach environments towing IRB trailer.

## ROLE SUMMARY

Perspective candidates must note that the requirement for Silver Medallion Beach Management (SMBM) has been removed from the RWC pre-requisites.

SLSNSW are currently developing an incident management training package for online delivery scheduled to be released in May 2024.

For candidates to exit the course as competent they will have to undertake and successfully complete the new incident management training package. As this is a 'change in progress' a flexible approach will be considered should the online training roll out be delayed.

The role of RWC Operator is a branch wide, broad ranging one and the RWC Operator is expected to be a competent solo operator. Operators will have rostered patrols allocated to them each season at a particular RWC location. Operators will also assist SLSCC Surf Sports by providing water safety at carnivals and other nominated events.

**Operators can be called out to assist people in all types of weather and sea conditions, often in adverse conditions, sometimes at remote locations.**

Rescues are often performed close to the shoreline whether rocky and/or sandy, inside the surf zone and frequently away from beach patrols with little immediate support. Operators will be relying on their training, radio communications and the rescue equipment, carried on the RWC, until support arrives.

Operators must be self-sufficient, responsible, mature and reliable, they must also work effectively in a team, with surf patrols and IRBs and also where a multi-agency response is required. Operators are expected to, maintain a reasonable level of fitness, have exceptional communication skills and maintain their operational skills and training as surf lifesavers.

Entry into the SLSCC RWC group is through a selection procedure whereby prospective candidates are deemed to have met, or are able to demonstrate they possess, the skills and qualifications required to undertake RWC operator training. The successful RWC Operator is a person with a mature character, high degree of commitment, dedication, experience and knowledge in Surf Life Saving.

## THE APPLICATION PROCESS

Applications will be accepted up to COB on Friday 10th May 2024

After the submission window is closed all applications will be checked against the members Surf Guard record prior to submission to the SLSCC BOLS. At SLSCC BOLS club endorsement is sought and BOLS members may endorse successful applications to proceed to the training stage.

Successful applicants will be notified by no later than Friday 24<sup>th</sup> May 2024 for induction on Saturday 1<sup>st</sup> June 2024.

**Please note that the induction day is considered mandatory attendance and is the gateway into the course, there will be no exceptions to this.**

This position requires an operator to interact with children and therefore a Working with Children Check (WWCC) is mandatory. Successful applicants will be expected to obtain a WWCC that has been verified in Surf Guard prior to being deemed competent as an RWC operator. **The WWCC is non- negotiable.**

Should the number of course ready applicants exceed the available training places you may be offered a place on a following course.
